REGULATION NUMBERS 58404 THROUGH 58412 REMOVALS

May 5, 2005

TO WHOM IT MAY CONCERN:

Pursuant to the authority granted in paragraph (b) of Section 70.38 of the "Code of General Ordinances of Kansas City, Missouri" and subject to the provisions thereof, traffic regulations are hereby made and adopted as follows:

The Maximum Speed Limit, as indicated below and as listed in Section 70-363, is hereby discontinued at the following location:

Regulation 58404 North Bennington Avenue from Northeast Russell Road to Northeast 48th Street Twenty-Five Miles Per Hour

Prohibition of **Stopping, Standing and/or Parking**, as indicated below and as listed in **Section 70-530**, is hereby discontinued at the following locations:

Regulation 58405 Wyandotte Street, east side, from a point 440 feet south of 141st Terrace then south 214 feet No Parking Anytime

Reserved Parking for **Handicapped Individuals**, as indicated below and as listed in **Section 70-534 and 70-535** is hereby discontinued at the following locations:

Regulation 58416 North Robinhood Avenue and

Northwest 87th Street Northbound

Regulation 58417 North Robinhood Avenue and North

Regulation 58418 Agnes Avenue and 21st Street Southbound

Regulation 58419 North Charlotte Street and Northeast 119th Street Eastbound and Westbound

Regulation 58420 North Jefferson Street and Northwest 52nd Terrace Eastbound and Westbound

Regulation 58421 North Poplar Avenue and Northeast 78th Street Northbound

The driver of a vehicle shall **Yield the Right-of-Way** to all vehicles approaching the following intersections, in the direction bound as indicated, when **Yields** are in place and shall be added to the list as contained in **Section 70-335**:
