

COMMITTEE SUBSTITUTE FOR ORDINANCE NO. 091057

Rezoning an area of approximately 4.7 acres generally located at the northeast corner of W. 103rd Street and Wornall Road from District C-2 to District PD/C-2, and approving a development plan for the same. (5772-PD-12)

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section A. That Chapter 80, Code of Ordinances of the City of Kansas City, Missouri, commonly known as the Zoning Ordinance, is hereby amended by enacting a new section to be known as Section 80-11A0860, rezoning an area of approximately 4.7 acres generally located at the northeast corner of W. 103rd Street and Wornall Road from District C-2 (Local Retail Business) to District PD/C-2 (Local Retail Business/Planned Development), said section to read as follows:

Section 80-11A0860. That an area legally described as:

Lot 1, Star II, a replat of part of Lot 1, Block 1, Indian Creek Subdivision;  
and Lot 1, Wolfe's Addition, subdivisions in Kansas City, Jackson  
County, Missouri, according to the recorded plats thereof.

is hereby rezoned from District C-2 (Local Retail Business) to District PD/C-2 (Local Retail Business/Planned Development), all as shown outlined on a map marked Section 80-11A0860, which is attached hereto and made a part hereof, and which is hereby adopted as a part of an amendment to the zoning maps constituting a part of said chapter and as an amendment to Section 80-11 thereof.

Section B. That a development plan for the area legally described above is hereby approved, subject to the following conditions:

1. That the developer submit a detailed micro storm drainage study, consisting at a minimum of a letter from a Missouri licensed civil engineer stating that the proposed improvements will not alter or increase historical runoff conditions for the site, to Development Services prior to review and issuance of any building permits, and that the developer construct any improvements as required by Development Services, prior to issuance of a certificate of occupancy.
2. That the developer submit a letter from a licensed civil engineer, licensed architect, or licensed landscape architect, who is registered in the State of Missouri, stating the condition of the sidewalks, curbs, and gutters. The letter must identify state of repair as defined in Chapters 56 and 64, Code of Ordinances, for the sidewalks, curbs, and gutters. It shall identify the quantity and location of sidewalks, curbs, and gutters that need to be constructed, repaired, or reconstructed. The developer shall secure permits to repair or reconstruct the identified sidewalks, curbs, and gutters as

- necessary along all development street frontages, as required by Development Services, prior to issuance of a certificate of occupancy.
3. That the developer submit plans for grading, siltation, and erosion control to Development Services for review, acceptance, and permitting prior to beginning any construction activities.
  4. That the developer secure a site disturbance permit from Development Services prior to beginning any construction, grading, clearing, or grubbing activities, if the disturbed area equals one acre or more.
  5. That the developer grant a BMP Easement to the City as required by Development Services, prior to issuance of a certificate of occupancy.
  6. That the developer submit a final plan to the City Plan Commission for approval, including detailed information on landscaping, signage (including elevations), lighting (including a photometric study showing zero footcandles at the property line and no direct illumination beyond the plan boundary) and building elevations.

A copy of said development plan is on file in the office of the City Clerk with this ordinance and is made a part hereof.

Section C. That the Council finds and declares that before taking any action on the proposed amendment hereinabove, all public notices and hearings required by the Zoning Ordinance have been given and had.
