070383 Vacating Bank Street from the south line of 7th Street to the north line of Garment District Place (platted 8th Street), Kansas City, Jackson County, Missouri, reserving utility easements, and directing the City Clerk to record certain documents. (1527-V)

070384 Rezoning an area of approximately 2.42 acres generally located from 10th to 11th Streets, between Locust Street and Cherry Street from District C-3b to District URD, and approving a development plan for the same.

070392 Approving an amendment to a previously approved development plan in District URD on a 4.87 acre tract of land generally located at the southeast corner of 45th Street and Main Street. (11744-URD-2)

070393 Rezoning an area of approximately .62 acres generally located on the west side of Summit Street about 300 feet south of 45th Street from District R-4 to District PD/R-4, and approving a preliminary development plan. (13716-PD)


