### AN ORDINANCE

APPROVING A FOUR YEAR USE AND LEASE AGREEMENT, EFFECTIVE MAY 1, 2005, WITH SIGNATORY AIRLINES AND AUTHORIZING THE AGREEMENT WITH TWENTY-SEVEN AIRLINES AT KANSAS CITY INTERNATIONAL AIRPORT; AUTHORIZING LIKE AGREEMENTS WITH ADDITIONAL AIRLINES; AUTHORIZING AMENDMENTS TO THE AGREEMENTS.

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the Four Year Use and Lease Agreement for Signatory Airlines at Kansas City International Airport, attached hereto as Exhibit A, is hereby approved.

Section 2. That the Director of Aviation is hereby authorized to enter into the Four Year Use and Lease Agreement with the following Signatory Airlines at Kansas City:
