THE CITY OF KANSAS CITY, MISSOURI  
THE CITY OF GRANDVIEW, MISSOURI  
THE CITY OF INDEPENDENCE, MISSOURI**

**2013 BYRNE JUSTICE ASSISTANCE GRANT (JAG) PROGRAM AWARD  
Grant Cycle October 1, 2012-September 30, 2016**

This Agreement is made and entered into this 28<sup>th</sup> day of June, 2013, by and between the COUNTY of Jackson (COUNTY), the CITY of Kansas City, Missouri (CITY1), the CITY of Grandview (CITY2), the CITY of Independence (CITY3),

**WHEREAS**, the U.S. Department of Justice, Office of Justice Programs has collectively allotted \$538,405.00 to the above-named units of government for state and local law enforcement-related initiatives; and

**WHEREAS**, each governing body agrees that the COUNTY of Jackson shall serve as the fiscal agent for the funds; and

**WHEREAS**, each governing body finds that the performance of this Agreement is in the best interests of all parties, that the undertaking will benefit the public, and that the division of costs fairly compensates the performing party for the services of functions under this agreement; and

**WHEREAS**, the COUNTY of Jackson agrees to provide CITY 1 \$248,114.00 from the JAG award for Neighborhood and Community Services and the Kansas City Metropolitan Crime Commission; and

**WHEREAS**, the COUNTY of Jackson agrees to provide CITY 2 \$15,048.00 from the JAG award to purchase Law Enforcement Related Equipment for public safety; and

**WHEREAS**, the COUNTY of Jackson agrees to provide CITY 3 \$47,130.00 from the JAG award to purchase Law Enforcement Related Equipment for public safety and a technology assistance contract;

**WHEREAS**, the COUNTY of Jackson agrees to receive \$228,113.00 from the JAG award for salaries and benefits for the Drug Court staff in the Jackson County Prosecutor's Office; and

**WHEREAS**, the COUNTY of Jackson, CITY1, CITY, and CITY3 believes it to be in their best interests to reallocate the JAG funds.

**NOW THEREFORE**, the COUNTY of Jackson, CITY1, CITY2, and CITY3, agree as follows:

**Section 1.**

COUNTY OF JACKSON agrees to pay CITY 1 \$248,114.00 of JAG funds.

CITY 1 agrees to use \$248,114.00 for Neighborhood and Community Services and the Kansas City Metropolitan Crime Commission.

**Section 2.**

COUNTY OF JACKSON agrees to pay CITY 2 a total of \$15,048.00 of JAG funds.

CITY 2 agrees to use \$15,048.00 to purchase Law Enforcement Equipment.

**Section 3.**

COUNTY OF JACKSON agrees to pay CITY 3 a total of \$47,130.00 of JAG funds.

CITY 3 agrees to use \$47,130.00 to purchase Law Enforcement Equipment and a Technology Assistance Contract.

**Section 4.**

COUNTY OF JACKSON agrees to receive a total of \$228,113.00 of JAG funds.

COUNTY OF JACKSON agrees to use \$228,113.00 for salaries and benefits for the Drug Court staff in the Jackson County Prosecutor's Office.

**Section 5.**

Nothing in the performance of this Agreement shall impose any liability for claims against all participating CITIES under this Memorandum of Understanding.

**Section 6.**

Nothing in the performance of this Agreement shall impose any liability for claims against any COUNTY.

**Section 7.**

Each party to this agreement shall be responsible for its own actions in providing services under this agreement and shall not be liable for any civil liability that may arise from the furnishing of the services by one or more of the other parties.

**Section 8.**

The parties to this Agreement do not intend for any third party to obtain a right by virtue of this agreement.

**Section 9.**

By entering into this Agreement, the parties do not intend to create any obligations express or implied other than those set out herein; further, this Agreement shall not create any rights in any party not a signatory hereto.




