WHEREAS, the City of Kansas City, Missouri, is threatened by severe weather in the form of thunderstorms, tornados and flash floods; and

WHEREAS, March is a pivotal month for severe weather hazards; and

WHEREAS, these hazards threaten life, property, the environment and our economic well-being; and

WHEREAS, all segments of our community should be prepared to reduce or eliminate the negative consequences of these hazards; and

WHEREAS, the Missouri State Emergency Management Agency has designated March as Disaster Preparedness Month; and

WHEREAS, the National Weather Service has set March 10-14 as Missouri Severe Weather Awareness Week; NOW, THEREFORE,

BE IT RESOLVED BY THE COUNCIL OF KANSAS CITY:


That the Mayor and Council hereby declare the month of March, 2003, as Severe Weather Preparedness Month for the City of Kansas City, Missouri; and
