BE IT FURTHER RESOLVED that this Resolution be spread upon the Minutes of the Council in testimony thereof and that a copy hereof be presented to Acting City Emergency Manager, Tanya Allen, with the advice to all citizens, businesses and government agencies to be aware of the threats posed by thunderstorms, tornados and flash floods, to be familiar with methods of keeping apprized of threatening situations, and to be prepared to minimize the negative impact of these hazards should they occur.
