BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the sum of \$200,757.00 is hereby appropriated from the Unappropriated Fund Balance of Fund 284, Local Law Enforcement Block Grant to the following accounts in the Fund 284, Local Law Enforcement Block Grant:
